**Subject:** Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from May 18, 2021 to July 13, 2021

**Requested Action: To Approve and Ratify Actions Taken by Executive Officer**

**The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).**

**Effective May 18, 2021:**

- **American Career College, Ontario, Vocational Nursing Program – Request Approved.**

The Program requested to increase class size from 60 students to 70 students for each part-time class, starting with the projected September 13, 2021, class, to replace graduating classes only.

- **Contra Costa Medical Career College, Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant initial approval to the Contra Costa Medical Career College Vocational Nursing Program for the four-year period beginning May 18, 2021 and issue a certificate accordingly.

Also, the Program requested to begin a vocational nursing program with an initial full-time class of 20 students on July 12, 2021, only, and graduating August 4, 2022.

Additionally, the Program requested approval of its 52-week curriculum, four 13-week terms, of 1595 hours, including 641 theory hours and 954 clinical hours with 50 percent live clinical simulation.

- **High Desert Medical College, Bakersfield, Vocational Nursing Program – Request Approved.**

The Program requested a full-time class of 20 students to commence on August 21, 2021 with an expected graduation date of September 28, 2022.

- **Stanbridge University, Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 45 students to commence May 31, 2021, with a graduation date of August 3, 2022, to replace the March 21, 2021, graduating class.

**Effective June 1, 2021:**

- **Cypress College, Psychiatric Technician Program – Request Approved.**

The Program requested to admit a full-time class of 24 students commencing on August 23, 2021, graduating on December 9, 2022, to replace the class that graduates on May 20, 2021.

- **North-West College, Pomona, Vocational Nursing Program – Request Approved.**

The Program requested to admit a one-time class of 20 full-time students to commence on June 14, 2021 with a graduation date of May 10, 2021 to replace the class that graduates June 11, 2021.

- **Marian College, Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 16 students to commence on July 12, 2021 with a graduation date of October 11, 2022 to replace the class that graduates on June 3, 2021.

Additionally, the Program requested to admit a part-time class of 16 students to commence on July 8, 2021 with a graduation date of March 18, 2022 to replace the class that graduates on June 12, 2021.

- **Cuesta College, Vocational Nursing Program – Request Approved.**

The Program requested the Board approve their request for a curriculum revision to increase from a 12-month to an 18-month program which will include 609 theory hours, 983 clinical hours with total program hours of 1592.

- **Institute of Technology, Clovis, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students commencing July 12, 2021, graduating August 12, 2022, to replace the August 13, 2021 graduating class.

Additionally, the Program requested to admit a full-time evening class of 30 students, commencing July 12, 2021 and graduating on August 12, 2022.

- **National Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students commencing July 19, 2021, graduating October 19, 2022, to replace the July 15, 2021 graduating class.

**Effective June 15, 2021:**

- **Allied Health and Medical Services, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time day class of seven students to commence on July 22, 2021 with a projected graduation date of January 7, 2023 to replace the class that graduates on July 17, 2021.

- **Angeles College of Nursing, City of Industry, Vocational Nursing Program – Request Approved.**

The Program requested a full-time class of 25 students to commence on June 28, 2021, with a graduation date of August 5, 2021.

- **Carrington College, Sacramento, Vocational Nursing Program – Request Approved.**

The Program requested a full-time class of 30 students to commence on August 9, 2021, with an expected graduation date of July 15, 2022 to replace the class that graduated July 30, 2021.

- **College of the Redwoods, Del Norte, Vocational Nursing Program – Request Approved.**

The Program requested a curriculum revision that includes a 69-week full-time program to include 700 theory, 1136.8 clinical hours which includes 59.28 simulation hours. The total program hours are 1836.8 hours.

- **College of the Redwoods, Eureka, Vocational Nursing Program – Request Approved.**

The Program requested a curriculum revision that includes a 69-week full-time program to include 700 theory, 1136.8 clinical hours which includes 59.28 simulation hours. The total program hours are 1836.8 hours.

- **Mission College, Santa Clara, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning May 11, 2021 and issue a certificate accordingly.

- **Professional Medical Careers Institute, Vocational Nursing Program – Request Approved.**

The Program requested to increase frequency of admission from one class of 30 students every six months to replace graduating classes only, to one class of 30 students four times a year, replacing graduating classes only. This program will not have more than four cohorts running at one time.

- **Southwestern College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for the Program for a four-year period beginning May 12, 2021 and issue a certificate accordingly.

**Effective June 29, 2021:**

- **Cerro Corso Community College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval of the Cerro Corso College Vocational Nursing program for the period of May 12, 2021, through May 11, 2025, and issue a certificate accordingly.

Additionally, the Program requested to admit a full-time class of 15 students commencing August 23, 2021, and graduating December 1, 2022, to replace the class that graduated May 6, 2021.

- **Hartnell College, Vocational Nursing Program – Request Approved.**

The Program requested the Board approve their major curriculum revision that includes a 48-week full-time program to include 596 hours of theory, 970 clinical hours, including 111 clinical simulation hours. The total program hours are 1566 hours.

- **Healthcare Career College, Vocational Nursing Program – Program Request Modified/Approved and NEC Recommendation Approved.**

The Program requested to admit a full-time class of 20 students to commence on July 12, 2021 with a graduation date of September 30, 2022, to replace the class that graduated on June 4, 2021.

The NEC recommended placement of the Program on the July 2021 Education and Practice Committee Meeting agenda for consideration of placement on provisional approval.

Decision: Approved class but drop class size to 16 students; and approved recommendation to take Program to the Education and Practice Committee Meeting on July 17, 2021.

- **Medical Allied Center Care Center, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 20 students commencing on July 26, 2021, graduating on May 7, 2023, to replace the class that graduated on June 13, 2021.

- **Unitek College, Bakersfield, Vocational Nursing Program – Request Approved.**

The Program requested to admit a class of 36 full-time day students to start on July 26, 2021 with an expected graduation date of July 13, 2022, to replace the class that graduates on July 9, 2021.

**Effective July 13, 2021:**

- **Beaumont Adult School, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 30 students commencing on September 14, 2021 with a graduation date of April 10, 2023.

- **California Career Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time evening class of 30 students to commence on July 27, 2021, with an expected graduation date of March 11, 2023 to replace the class that graduated on May 30, 2021.

- **Quest Nursing Education Center, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a one-time full-time **day** class of 30 students to commence on September 6, 2021 with a projected graduation date of September 30, 2022.

Additionally, the Program requested to admit a one-time full-time **evening** class of 30 students to commence on September 6, 2021 with a projected graduation date of September 30, 2022.

- **San Joaquin Valley College, Rancho Mirage, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on October 25, 2021 with a graduation date of February 17, 2023, replacing the class that graduates on November 5, 2021.

- **Stanbridge University, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a part-time class of 45 students to commence on July 26, 2021 with a graduation date of November 15, 2023.

Additionally, the Program requested to admit a full-time class of 45 students to commence on September 6, 2021, with a graduation date of November 2, 2022, replacing the August 8, 2021 graduating class.
